## ANTR2M - Teaching profile

### Learning outcomes

Students enrolled on the Master [120] in Anthropology course are working towards becoming professional anthropologists with the ability to robustly and expertly analyse societies and cultures, understand global and local contemporary changes and issues and their consequences, and act on them legitimately and effectively. UCL therefore seeks to produce anthropologists who are advocates of **prospective anthropology**, a direction that provides diagnostic instruments, is favourable to joint action practices and offers evaluation and intervention methods.

Students taking this course have previously demonstrated (e.g. via a SOCA or HUSO Bachelor degree, bridging course or by applying for accreditation of prior learning [VAE]) knowledge of the key concepts, fundamental theories and methodologies specific to anthropology, which they will use and develop as part of the Master's course.

On completion of their Master, graduate anthropologists will:

- have developed in-depth and critical knowledge of the fundamental principles and concepts of anthropology, culture and social life, in accordance with recent changes in contemporary societies;
- have specialised in one of the fields of anthropology (through their choice of focus);
- have developed an interdisciplinary foundation in anthropology with a view to collaboration with and openness to other disciplines;
- have incorporated anthropological "conversion" through the completion of a theoretical project based on the development of an anthropological viewpoint on a specific topic, including the construction of an original "debate" with a pertinent and logical dialogue between different authors and the development of a reasoned and well-argued personal position;
- be capable of designing and executing an anthropology field research project: designing and conducting an ethnographic field study using the participant observation method (dealing with the challenges and consequences arising from this, particularly with regard to the group being studied) by applying the relevant approaches and techniques (study, description, interpretation) and employing robust inductive scientific reasoning to prepare a research monograph;
- be able to use their knowledge, skills and a robust scientific approach to conduct a critical, multidisciplinary analysis of the issues of anthropology in the 21st century with ethical values in mind.

Through their choice of focus and the development of a research project (thesis), graduates undertake specialist training geared towards the following occupations:

- research, consultancy or high-level expertise in the field of ethnology and social and cultural anthropology (Research focus);
- the design, execution and evaluation of social, economic and cultural development projects in an intercultural context worldwide (Professional focus: social anthropology of interculturality and development);
- the design, execution and evaluation of projects concerning contemporary environmental issues and natural resource management in interaction with social and cultural issues (Professional focus: anthropology of nature, the environment and societies);
- teaching or training in the field of social sciences (Teaching focus).

Aware of the responsibility that goes with the role of anthropologist, graduates will have adopted a critical academic attitude, enabling them to make decisions completely independently, with civic and ethical values and public service being core concerns. They will have invested in a continuous development approach enabling them, as professionals, to demonstrate expertise, and the ability to adapt and evolve positively in their socio-professional environment.

On successful completion of this programme, each student is able to :

On completion of this programme and regardless of the choice of focus, graduates will be able to:

1. **Master and apply an approach incorporating the interdisciplinary fundamentals of anthropology to demonstrate and apply a body of specialist anthropological knowledge, as well as a knowledge base involving various disciplines related to anthropology in order to provide a better understanding and expert analysis of human groups and social phenomena.**

- 1.1. Demonstrate in-depth and critical knowledge of the fundamental principles and concepts of anthropology.
- 1.2. Demonstrate the acquisition of specialised anthropological knowledge and the development of their general knowledge.
- 1.3. Demonstrate the acquisition of a knowledge base in the disciplines related to anthropology (sociology, history, psychology, archaeology and biology) with a view to complementarity and openness (interdisciplinary foundation of anthropology).
- 1.4. Use and apply, in a pertinent manner, their anthropological knowledge in order to understand and expertly analyse human groups or social phenomena and their consequences, in line with recent changes in modern societies.
- 1.5. Demonstrate an ability to incorporate knowledge of other disciplines into the analysis of human groups or social phenomena and their consequences with a view to complementarity and openness (interdisciplinary foundation of anthropology).

2. **Develop an anthropological "conversion" point of view on a specific subject through the development and completion of a theoretical epistemological project, including the construction of an original "debate", with a pertinent and logical dialogue between different authors and the development of a reasoned and well-argued personal position;**

- 2.1. Explain and define the study topic and define the concepts used as a basis for questioning the topic with reference to specific cases.
- 2.2. Create a bibliography: list the classical and/or contemporary theoretical works in the discipline, as well as standard papers and interpretations by various authors contributing to the study of this topic, while examining their validity and relevance.
- 2.3. Demonstrate an in-depth, thoughtful and critical reading of the original and/or contemporary theoretical works in the discipline, as well as standard papers contributing to the study of this topic.

- 2.4. Create an "original" debate, including a dialogue between different authors: construct a reasonable argument using original or contemporary theoretical works and strictly appropriate standard papers structured in a logical manner.
- 2.5. Develop an anthropological point of view and a line of questioning that is part of the discipline (make the "conversion"): take a detached, engaged and involved view, appropriate to the role of an anthropologist.
- 2.6. Construct and defend a reasoned and well-argued personal viewpoint on the topic and issues studied.
- 2.7. Write a coherent essay on the topic studied that satisfies the writing standards for a scientific review article (introduction/conclusion, definition of the topic and the conceptual approaches chosen, linking the different sections, quality of writing and argument, bibliography).
- 2.8. Defend the theoretical work before a panel in the form of a reasoned, well-argued, inquiring and well-supported discussion and constructive exchange.

**3. Devise and execute an anthropology field research project: devise and conduct an ethnographic field study using the participant observation method together with additional methods and combined with theoretical knowledge, implementing robust scientific inquiry using inductive reasoning in order to write a research monograph (thesis).**

- 3.1. Provide an overall definition of the research project: the research subject, the initial questions and the ethnographic area.
- 3.2. Prepare as complete a bibliography as possible (encyclopaedia, bibliographical references, specialist reviews, library catalogues, unpublished sources), while questioning the validity and relevance of the sources with regard to the research subject.
- 3.3. Determine the methods, in addition to participant observation, planned for this research: archives, interviews, real-life accounts, census, questionnaires, etc.
- 3.4. Using the bibliography, prepare a "status report" on the research subject.
- 3.5. On the basis of the status report, accurately define the research subject and its various elements in order to reveal a previously unseen aspect of the research and provide it with an effective launch pad within the practical field project:
  - specify the location of the ethnographic area;
  - specify the boundaries in terms of time and space;
  - specify the ethnographic goal and the issues studied and make the initial working hypotheses more complex;
  - specify an initial conceptual framework (lines of enquiry).
- 3.6. Independently implement and manage an anthropological field research project, its challenges and consequences, particularly for the group being studied (restitution, joint construction);
- 3.7. Manage, in a professional manner, the collection and management of information during research (ethnographic survey) through the use of bibliographic, documentary and ethnographic files, audiovisual equipment and the creation of a field notebook (observations, interviews, impressions, descriptions, etc.).
- 3.8. Devise and implement a robust methodology so as to respond to the issues studied using, in a critical manner, the pertinent methods and techniques for gathering and analysing original data, taking care to include a variety of viewpoints (surveys, comprehensive observations, personal experience, real-life accounts, questionnaires, archives; description; interpretation).
- 3.9. On the basis of the ethnographic study, write a research monograph that satisfies the following criteria:
  - containing an account of field-level experience based on a participatory observation project;
  - containing a report of the experiences of a particular human group, in a given context, using anthropological work prior to this research project;
  - using an ethnographic writing style that incorporates descriptive accuracy;
  - containing an account of the collection of original high-quality data structured around one or more lines of enquiry and making pertinent comparisons;
  - demonstrating a hypothetico-inductive epistemological approach in which the field data are central to building the interpretation;
  - demonstrating precision in the use of concepts, as well as clarity and robustness in the presentation of theses, arguments and ideas;
  - demonstrating the ability to be concise and formulate conclusions.
- 3.10. Demonstrate a critical and ethical perspective in the research process, including compliance with ethical rules recognised by the discipline and in professional practice.

**4. Communicate in French and English in a professional manner, both verbally and in writing, while adapting to the target audience and context, as well as interacting and collaborating respectfully and constructively with the different players involved in a given situation.**

- 4.1. Communicate verbally and in writing on complex subjects in the field of anthropology (information, readings, observations, conclusions and the underlying knowledge and principles) in a correct, structured and logical manner and in accordance with the communication standards specific to the context, adapting the communication (content and form) to the target group and to the intended purposes.
- 4.2. Communicate articulately in English, verbally and in writing, in a clear, coherent and well-argued manner on general topics or issues relating to the field of anthropology. (Level B2 of the Common European Framework of Reference).
- 4.3. Develop the communication skills required in the appropriate language (according to the location of the work placement) in order to be able to carry out the field work placement in a professional manner (ethnographic survey).
- 4.4. Converse and interact respectfully and constructively with the different parties involved (from a socio-cultural perspective and based on their position, field of activity and area of expertise), demonstrating an ability to listen, open-mindedness, detachment and assertiveness.
- 4.5. Integrate and work effectively within a team and with different stakeholders in networks involved in a given situation (in multicultural learning and professional contexts (work placement), nationally or internationally).

**5. As an anthropologist and academic, act as a critical and responsible player, having already developed the skills appropriate for initial practical professional experience and being committed to continuous development.**

- 5.1. Build and embark on professional practice using a well-founded academic approach (from a theoretical and methodological perspective) characterised by critical objectivity.
- 5.2. Demonstrate an ability to detach themselves from their own views, prejudices and cultural values.
- 5.3. Work, make decisions and act independently and responsibly with regard to the framework, work context and others while respecting ethical values.
- 5.4. Demonstrate the ability to adapt to varied and complex situations related to the functioning of any human group.
- 5.5. Demonstrate awareness of their resources and professional skills in order to develop them independently (continuous development approach) and use these in the service of research or professional careers that require the application of multiple skills.

**In addition to these skills common to all Masters of Anthropology, graduates will have demonstrated a high level of professional skill in the field of the chosen focus.**

**If they chose the Research focus, they will be able to: demonstrate that they have developed and acquired the skills of a generalist specialising in ethnological research and social and cultural anthropology and start a doctoral project or move towards careers in research or consultancy**

## Programme structure

In addition to broadening knowledge of the areas that go to make up anthropology, a well structured piece of research is a key part of the 120 credit Master in Anthropology. It is possible to do a placement in the field to pursue basic research. This reflects the process of aligning anthropology and sociology, begun in the University in 1997, where there is a course on Socio-anthropology and also a professional focus, organized with the Sociology Department on the Socio-anthropology of Interculturality and Development.

The Master in Anthropology is centred on a research project selected by the student with the help of a tutor. This entails understanding how to do the so-called 'participant observation' (choice of location, outside placement, investigation, description, interpretation then production of a monograph - dissertation).

The 120 credit Master in Anthropology offers core subjects, optional 'area' subjects and three different focuses.

- the core subjects (75 credits) include courses on research techniques (29 credits) "theoretical cross-disciplinary issues" (20 credits), lectures where well-known researchers present their findings (Chaire Leclercq - 6 credits) and general subjects (20 credits).
- according to the area of their research project (15 credits), students may also choose options (for example trade, symbolic systems, town, gender, religion, kinship or globalisation) or a group of optional subjects.

The choice of one of three different focuses (30 credits each) will enable students to develop specific skills:

- the research focus develops basic research skills with a theoretical foundation and more rigorous methods of analysis ;
- the professional focus in the socio-anthropology of interculturality and development develops skills in identifying, carrying out and assessing development projects of an intercultural nature both in the Northern and Southern hemispheres ;
- the teaching focus develops teaching and training skills in the field of social sciences.

*Whatever the focus or the options chosen, the programme of this master shall totalize 120 credits, spread over two years of studies each of 60 credits.*

## Admission and Enrolment Procedures for general registration

Specific procedures :

Mature students may have professional experience accredited under the special procedure for accrediting prior learning and experience known as VAE (Valorisation des Acquis de l'Expérience). It is up to the board of examiners or their designated representative to determine admission criteria (besides admission, exemption up to a maximum of 60 credits may be awarded). For mature students, it is possible to enrol for the certificates successively and in a logical order in order to gain the relevant credits. At the end of this process they may enrol for the academic Master.

## Teaching method

---

The Master in Anthropology programme is designed around two main cornerstones: the production of a theoretical anthropological work and the preparation of a research monograph based on an ethnographic study (field study) conducted using the participatory observation method. To achieve this, a mentoring system (supervision of a small group of students by an academic and researchers) is set up at the start of the first year during a residential weekend giving students, teachers and researchers from the UCL Laboratory for Prospective Anthropology the opportunity to meet. Each student is then invited to select his or her course programme and to devise a research project in line with his or her interests, training objectives and career goals.

The Master's course employs a progressive and consistent training strategy based on four semesters spread over two years: classes in cross-functional methods and issues + preparation of an epistemological work (1st semester); foreign study visits via the Erasmus or Mercator programmes (2nd semester); study site (3rd semester); multidisciplinary classes and preparation of the research monograph (4th semester).

List of possible classes: "special fields" offers students a special and vocational option. It is also aimed at highlighting UCL's exceptional range of options in this area.

The quality of training is guaranteed by the structural and institutional links between the Master in Anthropology course and the members of the Laboratory for Prospective Anthropology (LAAP), which brings together some forty researchers in a dynamic team. This is made possible by the involvement of researchers in the programme (seminars, special classes and mentoring). The teachers and researchers work at different sites around the world and collaborate with a number of international anthropology laboratories.

The Chair, Jacques Leclercq, represents a major advantage for the UCL Master in Anthropology programme. The position of Chair is a guarantee of quality and contributes to the international reputation of our educational programme. The Chair gives us the opportunity to invite, twice a year (2 x 15 hours), two internationally renowned professors of anthropology not employed at UCL.

In addition, survey and data management tools using the latest communication technologies are available to students. A special anthropology media library is available at the ESPO Library (Faculty of Economic, Social and Political Sciences and Communication)

## Evaluation

---

*The evaluation methods comply with the [regulations concerning studies and exams](#). More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".*

The common core curriculum is assessed by a single examination before a panel of professors. The epistemological work is presented to them, supported by a tutoring report that must refer to the different elements of the common core. This exam is divided into two parts: submission of an 'integration of knowledge' work and an oral defence.

Assessment of other courses varies according to the subject taught (see course descriptions), the size of the group and the topics covered by the different teachers. There are several systems:

- oral or written final examination;
- final examination combined with exercises throughout the year;
- group work instead of an examination;
- individual work instead of an examination.

The assessment of the ethnographic site (field study) is conducted by the director of the research monograph (presence on site, adaptability and participation). The monograph is defended before a panel of academics (from UCL or other universities according to the subject) and researchers from the LAAP (Laboratory for Prospective Anthropology).

## Mobility and/or Internationalisation outlook

---

The programme contains many opportunities of an international nature, the most notable of which are the Jacques Leclercq Chair lectures. Each year UCL students can attend lectures, either in French or English, given by researchers of international standing.

In addition, the compulsory 3 to 6 month ethnography study, within the usual programme, enables students to study abroad if they wish. However, this study can also be done in Belgium in tandem with other activities in the programme. As far as students who also work are concerned, it may be organized in connection with their job (in Belgium or abroad). Agreements with many different European and North American universities also encourage students to be mobile. (The list of agreements is available from the POLS Department).

The conclusion of agreements with the Council of Universities ( [Conseil Interuniversitaire de la Communauté française – CIUF](#) and [Coopération Universitaire au Développement – CUD](#) ) to welcome students from the Southern hemisphere to study at UCL will further enrich the programme.

Finally, an international Master is under discussion which would place the UCL Master in a network of excellence in anthropology in collaboration with the universities of Aix en Provence, ULB (Brussels), Mainz, EHESS (Marseille), Roskilde, Uppsala and Geneva (IED).

Students would study a minimum of 30 credits at UCL.
